

Beginning a Business in the State of Montana

- 1. Select a business structure, here is a link explaining the options for structuring your business: https://www.sba.gov/business-guide/launch-your-business/choose-business-structure
- 2. Register your business with the Montana Secretary of State here: https://sosmt.gov/business/
 - a. When you're completing this registration, list yourself as the registered agent for your business
 - b. Select member managed if you are the individual responsible for making decisions for the LLC. Select manager managed LLC if you've handed over control of the LLC to an attorney
 - c. Incomplete LLC registrations are erased every night, try to finish your registration on the same day that you begin it.
 - d. Cost: \$70 for 12-month registration
- 3. As soon as you receive confirmation that your LLC registration is complete, apply for an employer identification number here: https://www.irs.gov/businesses/small-businesses-self-employed/apply-for-an-employer-identification-number-ein-onlin
 - a. When you have an EIN, we recommend opening a business bank account so that you can begin differentiating your business expenses from your personal expenses. This will make tax time easier for you.
 - b. Once your business bank account is set up, you can set up an owners draw, this is one way you can pay yourself through an LLC
 - c. There is no cost to get an EIN
- 4. Business operating within the city limits of Missoula will need to apply for a business license online here: https://www.ci.missoula.mt.us/129/Business-Licensing
 - a. General business licenses are renewed on an annual basis, expiring on May 31st of each year. The city of Missoula sends out an email at the beginning of April encouraging business to renew licenses online and then send paper invoices at the beginning of May. Paper invoices are mailed so that business owners have the option to pay by check. We highly encourage online renewal.

- Either way, SNAP sends the referral to Crystal & adds you to the next available program orientation that takes place on Mondays & Wednesdays.
